Message from the President

It is with great pleasure that I present the ESCC's Annual Report for 2019-2020. Through the work and activities of the past year, the Council has been engaged with its core mandate of representing the needs and defending the rights of English-speaking Catholics in Quebec. Working with community partners such as Catholic Action Montreal, Seniors Action Quebec (SAQ), Quebec Community Groups Network (QCGN), Quebec English-Speaking Communities Research Network (QESCREN), APPELE-Quebec and Community Health and Social Services Network (the CHSSN, on which Board I am privileged to serve), the ESCC has sought to improve the quality of life for Englishspeaking seniors, promote access to Englishlanguage health and social services, defend the rights of the minority language community to manage and control their educational facilities and welcome and integrate newcomers to the Englishspeaking community of Quebec.

The Council was gratified to see ESCC Advisory Committee member and former ESCC Executive Director, Martin Murphy awarded the Sheila & Victor Goldbloom Community Service Award for his long and exemplary service to the English-speaking community of Quebec. As a beneficiary of his expertise for so many years, the Council was pleased that Martin's role in the establishment of both the QCGN and CHSSN as pillar organizations that serve and represent the minority-language community was recognized and celebrated.

The staff, Board and Advisory Committee were saddened to learn of the death of Andrew Fogarty on February 14, 2020, just a couple of months shy of his 101st birthday. Andy was deeply involved in the life of the English-speaking Catholic community and was a founding Director of the ESCC.

The emergence of Covid-19, and the subsequent containment measures instituted by the provincial government in early March 2020, made for a very strange end to the fiscal year for the Council. Like so many other organizations, the ESCC quickly switched to online mediums for communication, governance and outreach and looked to other organizations to see where the Council could be of assistance.

I would like to thank each of the Directors of the Board for their generous contribution of time to the work of the Council. It has been a pleasure to serve with you. In addition, I would like to thank our Executive Director, Anna Farrow and our Executive Assistant, Suzanne Brown for their efforts on behalf of the Council.

Vision

Strategic Planning 2019-20

In alignment with our mission to act as a catalyst, convener and facilitator of community life and collective action for the English-speaking Catholic Community of Greater Montreal and to develop positions on issues of public concern which affirm and promote Catholic ideals and values, the Council will engage in the following activities:

- Participate with community organizations and initiatives which advance the interests of the English-speaking community in Quebec, with a particular emphasis upon, and concern for the English-speaking Catholic community.
- Work with community leaders to welcome and integrate new immigrants and newcomers to the English-speaking community of Quebec.
- Provide research and plan activities to improve the quality of life for English-speaking seniors. Address social isolation amongst English-speaking seniors of Greater Montreal Area.
- 4 Collaborate with established networks to promote access to English-language health and social services.
- Engage with community leaders and government representatives on life and education issues, including but not restricted to, abortion, euthanasia and palliative care.

Advocating

In the early part of 2019, the ESCC was approached to join a coalition being formed to oppose the provincial government's moves to eliminate elected school boards in favor of service centers. The Council became a supporting organization to APPELE, Alliance for the Promotion of Public English-Language Education, in March 2019 and has subsequently participated in press conferences and meetings to help raise awareness about the minority-language community and its rights to control and manage its educational institutions.

Bill 40, an enormous piece of legislation which includes some 84 separate amendments to provincial legislation, was tabled on October 1, 2020. The ESCC directly participated in the hearings organized by APPELE-Québec on November 19, 2019, in advance of select members of APPELE-Quebec appearing at the hearings held on Bill 40. The ESCC statement presented that day was delivered to Jean-François Roberge, Education Minister, by the APPELE-Québec team. The APPELE- Québec brief on Bill 40 notes that



In June 2019, the Executive Director was invited to join the Seniors' Committee of the Access to Justice project, funded by the Department of Justice Canada and implemented by the Quebec Community Groups Network (QCGN). The ED participated in meetings of the subcommittee and suggested several members of the community to the Seniors' subcommittee. The Council is excited to participate in this initiative and will continue to engage as this project evolves.


the legistlation is "unworkable and presents unnecessary obstacles to the exercise of our constitutional rights in its current format. We fear that it will discourage community and volunteer involvement and increase control of our school system by the education minister and officials in Quebec City."


The Council is closely following the court case launched by the Quebec English School Boards Association (QESBA) and the nine English school boards in June 2020. It will continue to support, in whatever way it can, the initiatives of APPELE-Québec.



Assisting

The survey entitled *Parishes & Newcomers*, developed by the Council in 2018-2019 and reported on at the 2019 Annual General Meeting, was distributed in hard copy form to three additional parish communities resulting in an additional 250 responses. Following the implementation of the surveys, focus groups within the parish context were planned to gather more information on the needs expressed in the surveys. Unfortunately, one of these focus groups was cancelled due to Covid-19 measures. In collating the information gathered from the over 600 responses collected, a strong need was expressed for some form of French language instruction or conversation groups within the parish context. Parishioners, who are newcomers, also reported the need for workshops on adjusting to life in Canada. The ED is currently meeting with partners from Concordia University, as well as leaders from the parishes, to explore the possibility of establishing conversations groups and/or homework assistance groups in select parishes. The development of these programs in parishes that have a high percentage of new immigrants is a continuing priority for the Council and will carry on into next year.





Catholic Action Montreal has been instrumental in the establishment of an informal coalition of organizations working with and for English-speaking seniors, One Voice. There are some 20 organizations associated with One Voice and each organization connects with between 250 to 2000 seniors in a year. Through regular meetings and workshops, the staff of these organizations are able to share information, discuss common challenges

and brainstorm solutions. The ESCC has collaborated with CAM in this enterprise through networking, organization, and in covering the costs associated with the One Voice meetings. In February 2020, on behalf of the One Voice Coalition, the ED drafted a letter to the Regional Access Committee requesting a 2-3 page brochure which, in clear and simple language, would explain

the provision of English-language services in the Montreal region. The concern is particularly for English speaking seniors who, as the letter states, often are bewildered as to how their rights to health care in English, "are made tangible in the current system, what the limits of those rights are, and where seniors should be pushing to receive services in English and where they do not, in fact, have a right to such service. We have seen that

this confusion leads to a reluctance to request services and written information in English or to report upon the lack of linguistic access." The right of the minority-language community to receive health and social services in English is one that is easily eroded. The Council is concerned to see that this right, where it exists, is safeguarded and defended.

Animating

The ESCC Christmas gathering for the English-speaking parishes of the Archdiocese was held on November 29, 2019 at St. Monica's Parish in N.D.G. At this event, the priests, wardens, staff, catechists, employees of the Archdiocese and Board members from the various organizations active in our community were able to socialize and enjoy a wine and cheese reception. At that reception, special mention was made by President of the Board, Paula Celani of the honor that former ESCC Executive Director, Martin Murphy had received in October 2019, namely the QCGN Sheila & Victor Goldbloom Community Service Award.





There is considerable irony in the fact that the ESCC public lecture scheduled for March 26, 2020, and then canceled in the wake of provincial guidelines, was entitled "Social Isolation and the Crowded City." If "social isolation" has been identified as particularly emblematic of our 21st century society, that isolation is now being experienced at an entirely new level and thought about in an entirely new way. Plans are currently underway for an online webinar on the topic of social isolation and a discussion of the community's response to Covid-19 and the lessons learned during the time of lockdown.
